ANNUAL RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In Consideration of being granted an annual membership and/or competition license and in consideration of being permitted to enter for any purpose any "restricted area" (herein defined as including but not limited to the racing surface, pit area, infield, garage areas and all walkways, roadways, concession areas and other areas appurtenant to any area where any activity related to the competitive racing event shall take place): **RELEASE AND WAIVER OF LIABILITY;** I, for myself, my heirs, next of kin, personal representatives and assigns, hereby release, waive, discharge and covenant not to sue the NORTHWEST SPRINTCAR RACING ASSOCIATION (NSRA), it's successors and assigns, the race organizers presenting NSRA events, the owners and lessees of the premises on which NSRA sanctioned events take place, the participants in NSRA sanctioned events, including care owners, drivers, mechanics, pit crews and any persons within the restricted area previously set forth, promoters, sponsors, advertisers, manufacturers of all racing equipment upon the premises and the officers, directors, officials, representatives, agents and employees of all of them (all of whom for the purposes herein are referred to as "releases") from all liability, loss, claims, demands, possible causes of action, court costs, attorney's fee and other expenses arising from any lawsuit that may otherwise accrue from any loss, damage or injury (including death) to my person or property in any way resulting from, or rising in connection with, or related to, any sanctioned event, and whether arising while engaged in competition or in practice or in preparation therefore, or while upon entering or departing from said premises, from any cause whatsoever including without limitation, the failure of anyone to enforce rules and/or regulations, failure to make inspections or the negligence of other persons.

ASSUMPTION OF RISK; I know the risk and danger to myself and property, both from known risk and unanticipated risk, while in or upon the restricted area or while participating or assisting in a sanctioned event, and I do so willingly, voluntarily, and in reliance, not upon the property, equipment, facilities and existing conditions furnished by others, but upon my own judgment and ability, and I therefore assume all risk of loss, damage or injury (including death) to myself and my property from any cause whatsoever and whether or not attributable to the negligence of others.

INDEMNITY AGREEMENT; I hereby agree to indemnify and hold harmless the releasers and each of them from any loss, liability, damage or cost they may incur to the presence of the undersigned in or upon the restricted area, whether caused by the negligence of the releases or otherwise.
